I further certify that my child has my permission to participate in the adidas Women's Invitational soccer tournament and related activities. In the event of injury or illness to our child, we hereby grant authority to a qualified EMT, athletic trainer and/or physician to render such medical treatment as said physician or other medical professional deems reasonable and necessary, and we also accept responsibility for any reasonable expenses involved with the treatment of any such illness, or injury, and treatment. The undersigned further agrees that he/she will defend, indemnify and hold harmless Williamson County Schools, City of Brentwood, Williamson County Parks and Recreation, Brentwood Academy, Vanderbilt University, and Brentwood Soccer Club for any subrogation claims which may be made for any and all medical expenses relating to or arising out of my child's participation the adidas Women's Brentwood Invitational.
